

#### **Essential Child Care Needs Covid & Beyond**



Due to COVID-19 school and business closures resulted in cascading affects to families, providers, businesses and schools. The statewide socio-economic impact of COVID-19 is significant. Moving beyond COVID-19 child care has a direct correlation to the resiliency and ability for the state to re-open. ENHANCE has a mission to ensure Montana re-opens more resilient by addressing the cascading affects and resources needed across families, providers, businesses and schools.

The results of this comprehensive survey will be publicly shared through a free webinar to introduce action plans that engage with community leaders including care providers, schools and businesses.






### Survey Responses | Total Responses 2,942

# **78%** of Families have had a negative\* employment impact due to COVID








Child care teachers are essential workers—let's treat them that way

But during this pandemic, they are being asked to serve children of other essential workers without the appropriate pay, health care, and personal protective equipment (PPE) or recognition that should come with risking their lives.

## Child Care in Montana

- → \$9,000 per year for infant care
- → \$8,000 per year for toddler care.
- → \$17,000 per year for care of an infant and toddler




Yet, Early Childhood Teachers earn on average <u>\$9.84</u> per hour

## Out-of-School Time (OST) in Montana

The role of the afterschool network:

- Data
- Quality
- Professional Development & Technical Assistance
- Policy
- Statewide Steering Council Leadership



Montana OST Programs:

- 200+ Afterschool & Summer
- 40,000+ students PreK-12
- School & Community Based BGCs, YMCAs, Parks & Rec., Museums

## Funding OST: Long Term & COVID-19 Impacts

#### Secure Access for Low-Income:

- 21st CCLC 29 Grantees/91 Centers
  - COVID-19 = Sustainable, flexible \$ virtual, distribute materials, PD & planning
- CCDF 5 School-Age Programs Licensed
  - COVID-19 = Expanded access for non-licensed emergency & summer

Other:

- Grants/Parent Fees/Community Support
  - COVID-19 = Unreliable, but not non-existent

#### • CARES Act

• PPP, SBA, Social Services by programs / Schools can use funds as well



## What OST Can Offer: This fall and beyond

- Keep kids connected and learning
  - Leverage existing relationships with kids and families
  - SEL and trauma-informed practices integral to academic success
  - Targeted partners for academic recovery
- Help parents return to work
  - Partner with schools to address child care needs
  - Community-based programs with non-school staff may play unique role
- Support safety and well-being
  - Be a part of response for COVID-19 safety
  - Integral part of network for safety from abuse and neglect



## FARALLY FRANKLY BARANA MONTANA

An initiative to strengthen Montana businesses through family friendly practices and policies





The following tiers range from organizational practices a business could adopt with relative ease, to those requiring a more committed investment. While varied, each of these practices provide a win-win for businesses and families.

#### **TIER 1: ORGANIZATIONAL PRACTICES**

- Offer flexible schedule, such as a compressed work week
- Offer telecommuting options
- Offer voluntary reduced work time options
- Provide the option to bring an infant to work for a period of time (i.e. up to 6 months)
- Connect employees with community resources and educate expectant parents on health care, leave planning, and support while on leave

#### **TIER 2: FINANCIAL ASSISTANCE**

- Offer Dependent Care Assistance Plans (DCAP)
- Provide Flexible Spending Accounts (FSA)
- Provide Child Care Subsidies
- Offer Paid Family Leave

#### **TIER 3: ACCESS TO CARE**

- Provide onsite child care
- Reserve spaces at local high-quality provider
- Coordinate back-up/emergency child care services
- Create a co-op child care center to serve employees of participating companies
- Provide back-bone support for benefits to a local child care provider
- Invest in the quality of a child care center or family home provider through the purchase of STARS to Quality materials, trainings, educational supports, etc.

## Funding

### Danica Jamison Greater Gallatin United Way

### **State Investments to Date**

CARES CCDBG Funding of \$10.1 Million (\$10,113,887) through MT DPHHS:

- Provided \$7,911,637 funding to 818 licensed childcare providers to ease a portion of their COVID-19 related program costs & losses:
  - First Round: \$8,000 to centers, \$5,000 to groups, \$3,000 to family providers
  - Second Round: \$5,500 centers, \$3,500 groups, \$2,500 family providers
- Provided \$782,771 funding for 15 temporary emergency pop-up programs.
- Provided \$1,419,479 reimbursement to cover 100% of family co-pays and childcare providers authorized costs for their Best Beginnings Scholarship students for the months of March, April and May.
- NOTE: Approximate funding amounts presented are subject to change as MT DPHHS may receive additional application requests for funding.

## **Resources Needed**

#### COVID-19 Extra Costs

- Higher staff to student ratio to reduce C-19 transmission risks
- Hazard pay needed to retain staff
- Health insurance, paid sick leave & PTO for staff
- Substitute staff on call
- Behavioral health consultation

#### **COVID-19 Extra Costs**

- More facility space needed for social distancing requirements
- Training & support for staff
- Sanitation + PPE
- Admin costs
- Remote learning needs: equipment / internet / staff to support & connect with school
- Families need scholarships

## **Funding Needed to:**

- Keep existing childcare facilities & OST 
   open through June 2021
- Reimburse childcare & OST providers for COVID-19 related outstanding debts & lost reserves
- Guarantee minimum 50% of operating costs for OST & licensed childcare facilities more if parent fees are not adequate to cover remaining 50% of monthly costs.



**Greater Gallatin United Way** kidsLINK Afterschool Program

- Provide hazard pay (\$20 per hour minimum wage) to all childcare staff
- Provide 100% of costs of health insurance for all childcare staff in MT
- Provide 100% of costs for behavioral health program level consultation, training and ongoing support for staff
- Cover 100% of costs for facility expansion
- Cover 100% of Sanitation + PPE

## **Cost Calculations**

#### Cost per Student per Day

- \$73.00 for 7 hr school day pre-COVID
- \$40.00 for full day (10 hrs) PIR day programming pre-COVID 19
- \$72.50 for full day (10 hrs) Emergency Childcare under COVID-19 conditions



Greater Gallatin United Way kidsLINK Afterschool Program

#### **Statewide Costs**

- \$5.7 Million for 12 months of continued support for Best Beginnings Scholarship families
  - \$31.65 Million min. needed for 12 months of continued support for licensed child care providers
- \$3.13 Million min. for 12 months of emergency childcare programs
- \$9.52 Million minimum needed for hazard pay + health ins + other greatergallatinunitedway.org
